The ToP[®] Advanced Facilitator Program is designed to help you have a deep impact on individuals, groups, and entire organizations. It prepares you to create a culture of participation and handle the most challenging facilitation situations in any organization. It also prepares you for the CTF certification as well as the Certified Professional Facilitators (CPF) certification issued by the International Association of Facilitators (IAF), which is the most recognized evidence of your

competencies as a professional facilitator worldwide. ICA ToP[®] facilitators are well-known for their profound respect of group wisdom and their ability to draw out wise results, motivation and commitment from group work in virtually every sector. This program is designed for people who want to significantly increase their ability to work with groups of any size in any company, community or government setting, to enable you to develop the capacities of an excellent facilitator.

Beginning in September, an additional format of the AFP will include:

- ▶ Fixed dates for a cohort of 12 people who work together over a year or more.
- ▶ Flexible dates for people who want to take the training at their own pace.
- ▶ A learning community connection and community among participants, which is crucial for knowledge sharing, collaboration, and peer exchange and supports.
- ▶ A diverse and dynamic learning environment that fosters active participation and engagement.
- ▶ Clear prerequisites and expectations of practices helps participants understand what is expected of them and provides a clear roadmap for success.
- ▶ Online platform for communication and networking creates a closer-knit community that can continue to support each other even after the program ends.

Contents of the Program

- The program includes ten courses (see detailed course description in Annex I)
- 18 hours of one-on-one mentoring over the course of the program
- The course format is mainly online, using two online platforms: Zoom and Mural.
- Courses can be taken in-person from the flexible schedule
- Participation in a monthly online AFP Community of Practice
- Participation in the facilitation practice platform on a volunteer basis, where one can apply the ToP facilitation tools and methods to real clients on real cases.

Mentorship

- ▶ Each student will receive 18-hour one-on-one personal mentoring. The mentor is an experienced facilitator who has obtained CTF. They come from different professional backgrounds, and you can choose a mentor that best fits your needs.
- ▶ The mentors will help you improve your core competencies required for CTF certification and assist you in preparing the necessary materials for the certification. They will help you fully prepare for the CTF certificate.

Program Fees

- ▶ The tuition of the AFP cohort program is a globally unified price, **CAD 16,960** plus tax. This includes all costs and fees for the course, personal mentoring, and CTF certification. There are twelve spots available for the fixed enrollment AFP, and more spots for flexible enrolment.
- ▶ The globally unified price: \$16,960.00 plus applicable taxes includes a 20% discount on all courses.

Professional Certification

This program addresses all IAF (International Association of Facilitators) competencies and all ICA ToP® competencies. Certification assessment is based on evidence from performance and separate from course work.

Appendix 1: Course description

Name	Overview	Dates
Group Facilitation Methods	This is a foundational course for professional facilitators, which provides a comprehensive foundation for facilitation practice. It goes beyond “sitting” facilitation and reliance on instincts, using the most powerful facilitation methods and processes. Learn a progressive approach, including clear thinking, rational decision-making, strong consensus, and open dialogue.	September 18-19, 2023 (other dates available)
Meeting That Work	This is a foundational course that includes a wealth of tools and practices. The course will provide you with professional skills, templates, and practical tools to increase commitment to action and handle difficult or controversial projects. With the best practices of professional facilitators, you can achieve benefits from meetings beyond your imagination. Turn meetings into “events” that people want to participate in, increase engagement, and get the best input and results from everyone.	November 1-2, 2023 (other dates available)
Facilitating Client Collaboration	This course shows how to collaborate with a client, co-discover their big challenges, co-manage a robust facilitation intervention, contract with the client and evaluate the results. Packed with tools, templates and sophisticated assessment methods. Facilitating Client Collaboration will prepare you to launch your own facilitation practice.	December 14-15, 2023 (other dates available)
Transformational Strategy	This course demonstrates how to lead participatory strategic planning and, perhaps more importantly, how to involve everyone in strategic thinking. By incorporating stakeholders’ perspectives into your long-term plans, you can maximize organizational strategic innovation, creativity, and flexibility. This course demonstrates how to facilitate groups with dysfunctional behavioral patterns and change these patterns by:</p> <ul style="list-style-type: none"> • Identifying the root causes of unproductive behavior. • Applying facilitation methods to support behavioral changes. • Redefining facilitation as a transformational skill. • Gaining a deeper understanding of facilitation methods. Leading Dynamic Teams	<p>This course is designed to provide participants with the skills and knowledge needed to lead and manage a high-performing team. Facilitating Conciliation	<p>This course shows the facilitative way for working through and getting beyond the entrenchment of multi-stakeholder, multi-issue conflict in order to propel organizations and parties forward. While conflict is built into life and is part of the creative process, negotiating from power and fixed positions deepens the divide and expands the problem. Learn alternatives to adversarial approaches in disputes. Rather than “managing” or “dealing with” conflict, this course works with the underlying root cause of systemic conflict. People can work together and form solutions even when conflict is built-in, normal and will not go away.</p>	<p>November 18-19, 2024 (other dates available)</p>
Participation Paradigm	<p>Understand why ToP™ methods are so successful in all situations and why they have such a profound impact on participants. The ICA method is based on cross-cultural research on human perception and experiential patterns over many years.
